Overview

There is often a disconnect between what we know and what we do in health care. In order to reduce this research-topractice gap, experts in behavioural and implementation science have studied barriers, facilitators and provided tools to ensure evidence-based interventions can be effectively delivered and scaled. The aim of this live-online course is to provide an introduction to behavioural and implementation science, and provide leaders and managers within the healthcare system with strategies to improve the uptake of interventions into routine practices, thereby increasing public health impact.

Learning Outcomes:

- Understand why behavioural and implementation science is important to health and healthcare.
- Identify factors that hinder the translation of evidence to sustainable practice and system change.
- Be able to describe and apply at least one framework for designing a behavioural and implementation strategy and apply this to a real-world health challenge.
- Be able to describe at least one innovative evaluation design that examines implementation and outcomes.
