Overview

This two half-day online course aims to train allied healthcare professionals to identify and address common ethical and moral issues in the clinical setting.

This course is designed to be interactive – consisting of short didactic sessions and online learning. The online learning will provide you with the foundation of ethical core values while the didactic sessions will hone your understanding of these values through group discussions, analysis of cases and application of ethical values and principles. You will be able to share your experiences and exchange ideas with other learners on applying ethical knowledge to existing work practices.

- Develop a sound ethical and professional approach to practice
- Acquire essential knowledge on the duty of care, consent, mental capacity, confidentiality, accountability, integrity and justice, grounded in Singapore's practice context
- Able to address the ethical and professional issues that occur in daily practice

PART 1 MODULES & READINGS IN CLINICAL ETHICS

Format: Approximately 4 hours of Online Learning Videos

What will be covered:

- Methods and principles of clinical ethics
- Consent and mental capacity
- End of life
- Communication and documentation
- Other contextual concerns

PART 2 CASE-BASED INTERACTIVE WORKSHOP

Format: 2 Half-Day Synchronous Online Sessions in Small Groups

(Ratio of 1 trainer to 8 participants)*

- Refusal of treatment
- Professionalism
- Respecting patient preferences
- Nutritional care and the patient's best interests
