## **CRiHSP Fellowship in Health Systems' Innovations Application**

### **Programme Overview**

The **CRiHSP Fellowship in Health Systems' Innovations** – a collaboration between the Centre for Research in Health Systems Performance (CRiHSP) and Behavioural and Implementation Science Interventions (BISI) at the NUS School of Medicine – is an 18-month part-time (no more than 0.3 FTE) programme designed to nurture promising professionals passionate about improving healthcare delivery through evaluation of innovations in health systems.

Fellows will gain hands-on exposure to health evaluation methodologies, lead an evaluation project under mentorship, and build networks with researchers, healthcare professionals, and policymakers.

### **What to expect**

Awarded fellows will be expected to:

- Attend regular supervision and sharing sessions with collaborating faculty and other fellow(s), once every 6-8 weeks.
- Develop and execute a feasible evaluation project within an 18-month period.
- Submit a final report at the end of 18-months.
- Communicate and disseminate evaluation outcomes, including, wherever feasible and appropriate, a publication on the proposed evaluation.

Fellows will have access to financial support, preferentially for buy-out of the fellows' time, although arrangements for research assistant support, or training can be alternatively accommodated. If there is a buy-out of fellow's time, the supporting department will be expected to match the protected time contribution. Exact arrangements will be agreed on a case-by-case basis.

- The evaluation proposal (item 3) should be no more than 2-pages.
- Ensure your Head of Department has indicated support (item 4) for your participation; unsigned applications will not be considered.
- Each applicant can only propose **one** evaluation project.
- The evaluation fellowship will commence **no later than 1<sup>st</sup> July 2026**.
- Shortlisted applicants will be invited for an interview with our faculty
