

Postgraduate Scholarship Options for MScBIS

BISI does not offer scholarships for our master's programme. However, you may consider applying for the following three external scholarships listed below. These scholarships are provided by reputable organizations and may cover various aspects of your study expenses. Please review each option carefully to determine your eligibility and application requirements.

1. Tan Kah Kee Postgraduate Scholarship

The Tan Kah Kee Foundation offers three postgraduate scholarships for Singapore Citizens and Permanent Residents (PRs) pursuing their full-time PhD or Master's degrees.

Successful applicants will each receive a one-off sum of S\$12,000 for studying in the university. All scholarships do not carry any bond. The scholarships are given out once a year, and successful applicants may re-apply annually.

2. Lee Kuan Yew Scholarship

The Lee Kuan Yew (LKY) Scholarship is the premier postgraduate scholarship in Singapore. Set up in 1991 by the Tanjong Pagar Citizens' Consultative Committee, it honours Mr. Lee Kuan Yew's contributions to Singapore and aims to recognise outstanding individuals with the aptitude and inclination to contribute to Singapore and our society.

Recipients can pursue postgraduate studies locally or overseas to develop their potential as leaders in their respective fields, with no bond attached, but are expected to actively contribute towards the betterment of Singapore and Singaporeans.

The scholarship covers full tuition fees and provides an annual allowance of S\$50,000 for up to 2 years for Master's degree studies or up to 5 years for PhD studies. Public sector awardees already sponsored by their agencies will receive a one-off sum of S\$10,000 instead.

3. NMRC Research Training Fellowship

The NMRC Research Training Fellowship (RTF) is awarded to outstanding clinicians and health science professionals for research training to have qualifications and skills to become Clinician Scientists. This fellowship supports research training in diverse areas, including MedTech, AI, Data Science, Epidemiology, Precision Medicine, and more.

Recipients can pursue local or overseas formal research training or research attachments, with awards covering up to S\$500k locally and up to S\$300k overseas for up to three years, with extended support for exceptional applicants pursuing PhD training.

Postgraduate Scholarship Options for MScBIS

Applicants must be Singapore citizens or Permanent Residents and hold primary employment in a local public institution. They must remain employed in a public institution throughout the award's duration and serve a bond with the Government of Singapore upon completing their training. The fellowship ensures full salary support, tuition fees, and allowances for research and conference participation.
