Robyn Mildon, PhD, is an internationally recognised figure in the field of evidence synthesis and translation, implementation science and program and policy evaluations in health and human services with particular expertise in early childhood. She is the Founding Executive Director of the <u>Centre for Evidence and Implementation (CEI)</u>, a global social purpose organisation whose work now spans across 8 countries.

Robyn is a Visiting Associate Professor at the Yong Loo Lin School of Medicine, National University of Singapore, Co-Director of the recently established Centre for Behavioural and Implementation Science Interventions (BISI), National University of Singapore, an Adjunct Associate Professor at Monash University in Australia, and Chair of the Evidence and Implementation Summit 2021 (www.eisummit.org).

Over her career, Robyn's work has helped to advance the implementation of better evidence in policy and practice settings, improving the quality and effectiveness of health and human services. She has been a keynote speaker at multiple events around the globe and designed and led a number of workshops to train students, policy makers and practitioners in implementation science and evaluation methods. Robyn has authored or coauthored multiple peer-reviewed publications, commissioned evidence reviews and book chapters. She is also a Co-Author of an edited book *Implementation Science 3.0* (Springer, 2020).

Dr Chong Shang Chee currently heads the Child Development Unit (CDU) and works with the Ministry of Health on meeting the national objectives and ministry directives on the National Child Development Programme. Under this program, she is also involved in the national development of policies with other ministry partners in special needs education, early childhood practices, as well as early intervention services. She is currently also serving on the Maternal and Child Health wellbeing taskforce at Ministry of Health looking at the health and well-being of mothers and children in Singapore.

Some of the projects that she has designed include the Heads-Upp (HEAlth and Development Support in Preschool Partnerships) study—designing a place-based paediatrics model of care which includes the timely delivery of health and development screening to low-income children; and evaluating the use of telehealth technology as an innovative way to enhance early intervention practices for children with autism spectrum disorder. Believing in family-centered practice, she also helped to establish NUH Child Development Unit as the first Brazelton Touchpoints site in Asia. Dr Chong is also teaching faculty at the Yong Loo Lin School of Medicine and frequently brings education into communities for parents, teachers, and early childhood service providers. She truly believes in partnerships and the value of working with and through systems around children and families.

Brian Bumbarger, PhD, works at the intersection of research, public policy, and practice to improve outcomes for youth, families, communities and public systems. He serves as adjunct research fellow at Griffith University (Queensland, Australia) and holds faculty appointments at Colorado State University, Penn State University and Arizona State University. He leads a Colorado-based consultancy supporting philanthropies and government agencies throughout the U.S. and internationally in the implementation and scale-up of evidence-based practices.

Dr Bumbarger served as the Founder and original Principal Investigator of the Evidence-based Prevention and Intervention Support Center (EPISCenter.org) one of the first statewide backbone organizations in the U.S., supporting the largest statewide scale-up of community collective impact coalitions implementing a diverse menu of evidence-based program replications. Brian was elected to the Board of Directors of the international Society for Prevention Research (SPR) from 2012 – 2015, and was recipient of the Society's 2014 Translational Science Award and 2020 Service to SPR Award for his research on scaling evidence-based practices. He serves on the Steering Committee of the Coalition for the Promotion of Behavioral Health, and is a founding member of both the Society for Implementation Research Collaboration (SIRC) and the Global Implementation Society.
